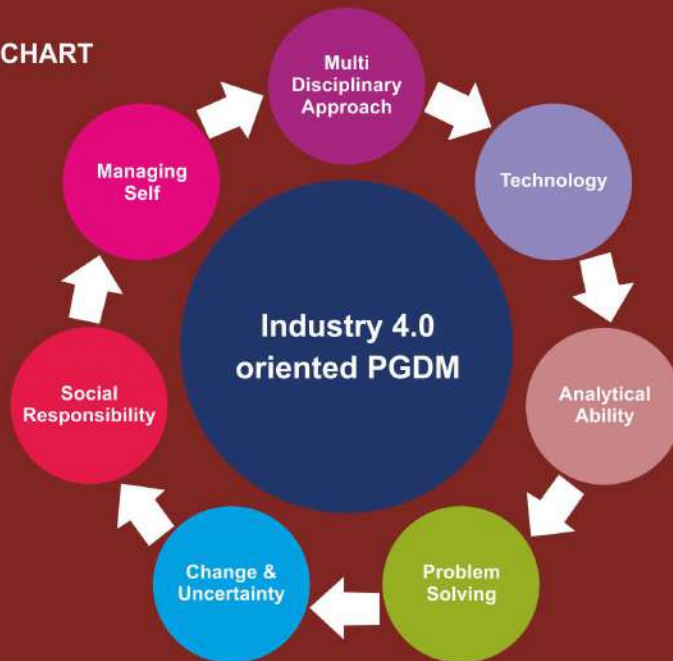

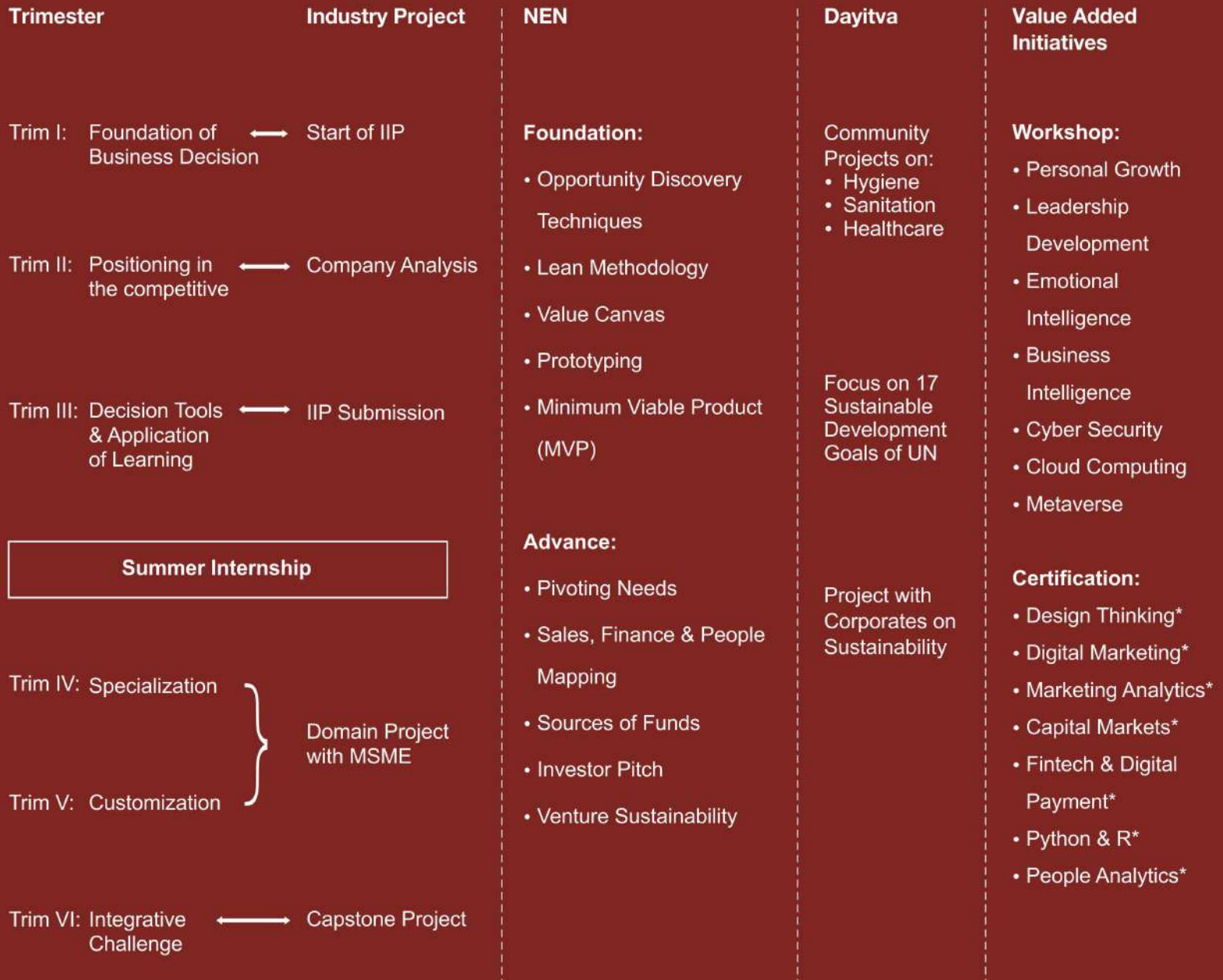
The PGDM program has six trimesters with eight weeks of summer internship along with six specializations:

ADMISSION PROCEDURE

Eligibility

- As per AICTE guidelines.
- Graduates in any discipline with 50% marks (45% in case of reserved category) recognized by the AICTE, UGC, AIU are eligible for the program.
- Candidates appearing for the final year Bachelors or equivalent Degree examination are also eligible to apply, provided they complete all the requirements of the qualifying examination.

Selection Criteria

- The candidates shall be short listed on the basis of the overall rank computed taking into account of the following components and their weightage:
- Score in the Common Admission Test (MAH-CET, CMAT, CAT, GMAT, XAT, MAT, ATMA)
- Score for academic performance in X Std., XII Std., Under Graduate Degree/ Post Graduate Degree
- Group Discussion / Personal Interview
- Sports, Extra-Curricular activities, Academic diversity and Gender diversity
